### Message from Caroline Wallis, Municipal Recovery Manager

We have been through a lot since the fire started on 16 December, 2014, only to see it reappear again on Christmas Day. The various ways in which the community responded to this emergency throughout the long period of response and mop up has been outstanding. A common theme that has emerged from all of the feedback received from the wide range of agencies and support services has been the capacity of the community to help each other, to help themselves and to be prepared.

Whilst there have been challenges, indeed more than a few, as there inevitably are in these times of emergency, the overwhelming picture that has emerged is of a community of people who care and are willing

to give up so much for each other. It has been a privilege for me to be involved as a CFA firefighter, a Creighton's Creek resident, and a Council officer and I know why I love living in this part of the country.

The Relief effort that commenced on the first day of the fire has been enormous. 127 residents registered with the Red Cross at the Wesley Hall Relief Centre in Euroa during the first few days of the fire. Staff members from the Red Cross, the Department of Health and Human Services and Strathbogie Shire Council were present to provide support and assistance for people who needed a safe place to gather. Other agencies provided information at community meetings and workshops. All of this effort means that our community has received, and continues to receive, what it needs to recover from this event.

During the days of response, both at the height of fire fighting efforts on 16 and 17 December and again on 25 December, and the many days in between and continuing right up until New Year's Eve, I can say that the effort put in by everyone involved was truly immense. Every person able to help in some way did so.

I would personally like to thank all of the Council staff members who volunteered many hours of their time to staff the phones, the relief centre and the Council's coordination centre. Our outdoor crews worked tirelessly to make the roads safe, with many giving up their time on Christmas Day to be available when needed. I also would like to thank all of the members of my team who provided much needed organisation and support in the Relief Centre when I was unavailable. As a small Council we all wear multiple hats, and my team dropped what they were doing to focus on helping fire affected residents during that first terrible week. Robbie Rae performed most competently as the Recovery Manager in setting the centre up in difficult circumstances and then remaining on site for many days to provide information and support to residents.

Our Director David Woodhams and CEO Steve Crawcour provided essential leadership and support during this time and made sure that whatever needed to get done was done. David also spent many hours on a truck in his other role as CFA firefighter. Roy Hetherington, our Director of Asset Services and his team have been working tirelessly throughout the event to make sure our roads are safe and accessible and response agencies had access to the equipment they needed.

I'd also like thank Brian Kelly for keeping me safe on the back of the truck and my husband Bernie for his unflagging support and commitment to the fight, even with his dodgy hip! There are just so many people to acknowledge so I know I have left many of you out. All I can say is thank you. You know who you are.

# **Recovery Committee and Plan**

Under the Council's Municipal Emergency Management Plan a Community Recovery Committee has been formed, and one of the first jobs for the Committee is to formulate and agree on a Recovery Plan. The Plan will provide a summary of the fire event; list the members of the Recovery Committee, its aims, and outline the objectives of the Plan with actions and timelines. The objective of the Recovery Committee includes:

- Identifying the needs and resource requirements
- Coordinating information, resources and services
- Liaising, consulting and negotiating
- Monitoring the recovery process

Copies of the Plan, community newsletter and other information will be available on Council's website as soon as possible.

The Committee will meet fortnightly and comprises local representatives of the key response agencies, Council, and community representation by the Brigade captains from Crieghtons Creek, Longwood, Gooram and Ruffy. #### **Key Issues**

Some key issues have been identified so far in community meetings, community feedback and the first Recovery Committee Meeting held on 15 January 2015.

These issues and the strategies discussed to deal with them now and in the future include:

- 1. Traffic Management Points (TMP). It was acknowledged that there were some issues with traffic management points, and in particular the ease with which key services were able to pass through. Some delays and difficulties were present in the early stages, including access by veterinary staff and stock feed suppliers. These problems have been raised with key regional personnel to ensure improvements in future. A suggestion was made to provide the TMP personnel with a contact list of key local agencies, such as local vets, to assist them in identifying quickly which services should be allowed through early on.
- 2. Waste disposal of fencing materials. Care should be taken if burying fencing materials and ensure that action complies with the EPA requirements. Council is investigating potential for burial pits and will advise the community if this can be provided. Metal recyclers may collect the material the best course of action is for landowners to contact the recylers directly.
- 3. Communications. Absentee rate payers who do not live full time in the Shire have requested information be available on Council's website. Council is working hard to set up a dedicated web page and this will be available as soon as possible.
- 4. Trees over fences. Support to clean up trees pushed over fences in the efforts to make roadsides safe will be provided. Coordination of requests is through the Council's Muncipal Recovery Manager.
- 5. Control lines. Support to restore control lines will be provided. Coordination of requests is through the Council's Municipal Recovery Manager.
- 6. Animal Welfare. DEPI conducted initial animal health assessments on day 2 of the fires however often stock exhibit health problems associated with the fire several days after the event. A request has been put to DEPI to include follow up visits several days after the intitial assessments to support farmers with decision making for future events.
- 7. Weibye track access. The track is a fire access road and will be dealt with by CFA to ensure good access is maintained.

# Request for timber

Janet Hagen has advised that the Goulburn Broken Catchment Management Authority has funding to collect three tip truck loads of timber to be used as habitat in the Hughes Creek catchment. In particular timber with hollows and root ball intact is sought. However any type of larger pieces can be used. ### **SAFETY CONSIDERATIONS**

- Beware of falling trees and branches, including both burnt trees and heat- affected ones
- Beware of onlookers on roadsides, and emergency vehicles on roads
- Beware of wandering livestock
- Understand that many residents are fatigued and in need of support

#### **BUSHFIRES AND WATER TANKS**

If you live in a bushfire affected area, you should be aware that your private water source could become contaminated. If your water looks, smells or tastes, funny, it may be contaminated from debris, ash, fire retardants or dead animals. You should not source water from a creek that has been affected by bushfire as the water may be contaminated. Water drawn from deep bores or wells should still be safe to use. If you suspect contamination, use an alternative water supply for drinking and food preparation.
