Summary

The purpose of this report is to receive / hear submissions made under Section 223 of the Local Government Act 1989 ("The Act") in relation to the 2017-2021 Council Plan (2019) Review and 2019/2020 proposed Budget.

The closing date for submissions was Tuesday 21 May 2019 at 5.00 p.m.

There were no submissions received for the 2017-2021 Council Plan (2019 Review), and eighteen submissions received for the 2019/2020 draft Budget. Five submitters requested to speak to their submissions. Copies of all submissions have been distributed to Councillors for their information and are tabled for identification purposes.

The Act further requires, under Section 125(7), that Council must consider whether the current Council Plan requires any adjustment. This process satisfies this requirement.

Consultation

Council's proposed Council Plan Review and proposed Budget have been on public exhibition for the statutory period of at least 28 days and submissions were invited from the community.

The 2019/2020 draft Budget provides funding allocations and support for nominated projects to proceed in both operational and capital works budgets, and, where appropriate, further community consultation will occur throughout the year specific to each project.


