# Summary

On 27 September 2019, the Federal Government announced the Strathbogie Shire is eligible to apply for up to \$1 million in Funding under an Extension of the Drought Community Program which is administered by the Department of Industry Innovation and Science. The Responsible Minister is the Hon Karen Andrews.

The Funding is in the form of a non-competitive Grant. The objectives of the program are to deliver support to targeted drought-affected regions of Australia by funding:

- Local community infrastructure and other drought relief projects.
- Funding will target infrastructure and other projects that:
- Provide employment for people whose work opportunities have been impacted by drought stimulate local community spending
- Use local resources, businesses and suppliers
- Provide a long-lasting benefit to communities and the agricultural industries on which they depend.

The funding is subject to an Eligibility Criteria with all submissions to be made before 1 June 2020 and all works completed by 30 June 2020.

On 15 October 2019, Council selected the following projects for further scoping and costing -

- Summer employment program repairing, improving and creating new walking trails e.g. Seven Creeks track in Strathbogie, Ruffy Snow Gum track, Hughes Creek at Tarcombe, Polly McQuinns to Gooram Falls, there will be more in the other wards Kirwans Bridge to Nagambie. Would need a DELWP partnership. Creek Drive along Kennedy to Weir Street, connectivity Apex Walking Track to Balmattum Hill track
- 2. Temporary splash Park Nagambie
- 3. Footpath Rehabilitation and street including Creek Drive along Kennedy to Weir Street Euroa

- 4. Bore and storage tanks plus pump shed power to all our towns. Violet Town, Strathbogie, Longwood, Graytown, Avenel, Ruffy possible new standpipes to allow access to water
- 5. Upgrading Avenel Tennis Club Clubrooms

The progress of these projects is demonstrated in the attached spreadsheet

In addition, the following further suggestions have been made by council staff for Council consideration -

- 6. Installation of more water tanks and further rooftop harvesting at the Euroa Sale yards
- 7. Partnering with Land Care Groups to deliver weed control training to farmers
- 8. Directing funding to setting up facilities to utilize recycled water to irrigate Parks and sporting fields in Euroa

Consultation with the Department and reference to the eligibility Criteria indicates that has revealed that suggestion 7 would be unlikely to succeed as there are other grant programs available to provide this training and the Economic stimulus would be limited.

Suggestion 8 would also be very unlikely to succeed as there are a significant number of studies and investigations that have to be carried out before any works could be undertaken (studies and investigations are ineligible activities under the grant guidelines) and the project would be unlikely to be completed by 30 June 2020.

The grant Application must be submitted through an online Portal. Despite several enquiries as at 1 November 2019 Strathbogie Shire has not been granted access to the portal and the application process. The Department advises that this access will be granted "soon".

### Summary

At the Ordinary Council meeting on 17 September 2019, Council resolved to undertake a Section 223 submissions process calling for submissions in relation to a proposed road deviation process be undertaken to provide legal access to the recently upgraded bridge over Faithful Creek at the end of Dip Lane, Balmattum.

Submissions closed on 23 October 2019. Two submissions regarding the proposal have been received (refer Attachment A), with one submitter requesting to be heard in support of their written submission.

### RECOMMENDATIONS

That Council resolves to -

- 1. Receive and note the submissions received in response to the public advertising of the proposed road deviation process at Dip Lane, Balmattum.
- 2. Hear those who wish to be heard in support of their written submissions.
- Formally consider all received submissions and the proposed road deviation at Dip Lane Balmattum at the Ordinary Meeting of Strathbogie Shire Council to be held on Tuesday 19 November 2019.

## Background

Council's recent bridge upgrade program included the replacement of bridge No.142 on Dip Lane in 2017-18 and the re-decking of bridge No.143 on Dip Lane which was completed in 2018-19.

Bridge No.143 across Faithful Creek provides the only legal access to Lot 3 LP117170. It also provides access to Lot 2 LP122627. The owner of this lot owns property on both sides of Faithful Creek.

The road reserve on the approach to bridge No. 143 is not aligned to the location of the existing bridge. (refer attachment A)



# 6.7.2 Proposed Road Deviation at Dip Lane, Balmattum

- Receiving / Hearing of Submissions (cont.)

Information provided by DELWP indicates that subdivision of the land in 1978 required the developer to construct a bridge (Bridge No. 143) and to construct the approach road. The formal road was never constructed and practical access to the bridge has been gained by a track across private property.

In conjunction with the bridge renewal works it has been the intention to formalise the legal access by a road deviation. Consultation with the affected owners has been carried out over a period of time and they are supportive of the proposed deviation.

Surveyors were engaged to prepare the road deviation plan which shows the area of road to be acquired by agreement (R1) from Lot 10 on TP944922 and the area of unused road to be transferred to the adjoining owner.

The plan (refer Attachment B) shows the area of unused road to be closed (cross hatched) and the area of road to be opened (hatched).

The provisions of the *Local Government Act 1989* Section 207B, Schedule 10, Clause 2 support the proposal.

The proposed road deviation involved a *Local Government Act 1989* Section 223 exhibition process which has now been completed.

Two written submissions have been received with one submitter requesting to be heard at the Hearing of Submissions on 12 November 2019.
