5.7.1 Proposed Nagambie Triathlon - Nagambie Sufferfest Multisport Festival - Request for Council Approval for Local Road Closure ~ Hayshed Road, between Grimwade Road and Goulburn Weir Road, Nagambie

Report Description:

Council to approve a local road closure for a triathlon event in Nagambie on Sunday 29th January 2017.

The author of this report and officers/contractors providing advice in relation to this report do not have a direct or indirect interest, as provided in accordance with the *Local Government Act 1989*.

Summary

The event organiser (Event People) is seeking Council's and VicRoads approval to conduct a triathlon event in Nagambie on Sunday 29 January 2017.

This proposed event will require Council's authorisation of a short-term full road closure of a local Shire road.

RECOMMENDATION

That Council approve the short term full road closure of the following road on Sunday 29th January 2017:

 Hayshed Road between Grimwade Road and Goulburn Weir Road (6.00am – 12.00noon)

under Section 207 and Schedule 11, Clause 10 (1) (b) of the Local Government Act 1989 "Power to place obstruction or barriers on a road temporarily".

Background

 Council has been working with Event People, Game Traffic Management and VicRoads to devise a suitable Traffic Management Plan for the proposed Triathlon event 'Nagambie Sufferfest Multisport Festival' to be held in Nagambie on Sunday 29th January 2017.

5.7.1 <u>Proposed Nagambie Triathlon - Nagambie Sufferfest Multisport Festival</u> - Request for Council Approval for Local Road Closure (cont.)

- The triathlon event comprises of three legs (swimming, running and bicycle riding). The swimming leg will be conducted in Nagambie Lake. The running leg will be conducted on footpaths in the Elloura estate. The bicycle riding leg will be conducted on both VicRoads and Council roads.
- The staging and transition area for the bicycle riding leg will be located at the south end of Jacobson's Outlook
- It is expected the finish line will be a gantry on the High St near Jacobson's Outlook to maximise the economic impact on the Nagambie's businesses.
- Prior to, and on the day of the event, the organisers will implement VicRoads approved variable message signs on the GV Freeway and within Nagambie township to inform road users of the proposed temporary road closures and altered traffic flow / detour conditions.
- Prior to the event, the organisers will place local newspaper advertisements to inform the public of the proposed road closures.
- The road closures will be in place from 6:00am to 12:00noon, with the event expected to run from 7:00am 11:00am.
- VicRoads have already provided "in-principle" approval for this event to take place on High Street (between Goulburn Street / Racecourse Road) and Grimwade Road (between Racecourse Road and the north GV Freeway interchange)
- Event People has been liaising with Nagambie Lakes Tourism & Commerce to speak to businesses and provide them with details of the event. The organiser spoke to businesses on Thursday 11 August.

Alternative Options

The author and other officers providing advice in relation to this report have considered potential alternative courses of action. No feasible alternatives have been identified

Risk Management

The organiser of this event is required to provide Council and VicRoads with detailed event management and traffic management plans, a thorough risk assessment and evidence of the required public liability insurance policies. The relevant officers within Council and VicRoads will assess all of this submitted documentation and determine that all of the required measures are in place for this event to take place safely.

This event will attract a significant number of people to Nagambie, both from within the local community and also from further afield. This influx of patrons attending this event will provide significant economic benefits to many local businesses.

Environmental / Amenity Implications

The author of this report considers that the recommendation has no significant environmental or amenity implications for Council or the broader community.

Community Implications

- A church service will be taking place at St. Malachys Catholic Church (363
 High Street) while the road closures, detours and altered traffic flow
 conditions will be taking place on High Street for this event.
- The northbound lane of High Street between Goulburn Street and Vine Street will be closed for the duration of the cycling leg of this event. The only onstreet car parking available along this section of High Street for this period will be on the southbound lanes on the opposite side of the road.
- Some local residents may experience minor vehicular transit delays as a result of the proposed altered traffic conditions
- VicRoads will only approve northbound traffic to travel on Grimwade Road (between Racecourse Road and the northern freeway interchange) during the event. Vehicles traveling southwards on the GV Freeway intending to access Nagambie will be directed to the southern freeway interchange.

- The event organiser has been liaising with Nagambie Lakes Tourism & Commerce to speak to businesses and provide them with details of the event. He spoke to businesses on Thursday 11 August.
- Residents along High St will be notified with letter drops.
- Notification of this event and road closures will be advertised in the local media.
- There will also be VMS (Variable Message Signs) placed at strategic places (on the GV Freeway and within Nagambie township) in order to inform people in the lead up to the event.



Summary

Concept proposals for the

- Establishment of a Visitor Information Centre at Jacobsons Outlook, and
- Introduction of angle parking, combined maneuvering and bicycle lane throughout the town centre

are brought forward for Council consideration (refer attached plans).

An opportunity can be taken to undertake community consultation on both projects concurrently.

RECOMMENDATION

That Council:

- Support the establishment of a Visitor Information Centre on part of Lot 2 TP515313U, (area approx. 55m²), by the adjoining landowner subject to consideration of submissions.

Background

The developer of the proposed café, restaurant and brewery is offering to construct a new purpose built Visitor Information Centre (VIC) and lake access staircase for Council on Council owned land (Lot 2 TP 515313U, High Street); building area approximately 55m².



5.7.2 Nagambie Tourism Enhancements (cont.)

The proposal would see: -

- The developer meet construction and initial maintenance costs for the facilities.
- Council operate the facility, meet outgoings and act as agent for Goulburn Explorer bookings.

A development agreement will need to be established between Council and the adjoining landowner prior to the Visitor Information Centre construction proceeding.

The planning application for the restaurant and brewery is currently on exhibition, with the additional VIC project shown on the plans. Enquiries received from the public have been on the subject of car parking.

The angle parking proposal provides approximately 7 angle parking spaces for every 4 parallel spaces in front of the development. It also provides approximately 14 long vehicle parallel spaces against the median.

The overall angle parking proposal has been developed in response to Council's 2016-17 Council Plan, Section 6.5 Strategy "Investigate and introduce angle parking in Nagambie Main Street".

The proposal is, where possible, in accordance with the Main Street Masterplan. Approval in principle has been provided by VicRoads.

Concept planning would benefit greatly from Community input and Council assessment prior to seeking formal VicRoads approval.

Overall, the angle parking proposal increases through lane kerbside parking spaces as follows: -

The central median carpark has not been altered in the concept. If that was to occur, a loss of car spaces could result.

Alternative options

The introduction of angle parking is the only option available to increase parking space utilizing the available inner traffic lane. The inner lane acted as the old heavy transport lane prior to the construction of the Nagambie bypass.

Risk Management

The author of this report considers that there are no significant Risk Management factors relating to the report and recommendation.





5.7.3 Violet Town Flood Mitigation Project

The author of this report does not have a direct or indirect interest in any of the matters referred to in this report.

Summary

Council has undertaken a process of Community Consultation to gauge the level of support for the Violet Town Flood Mitigation Project, proposed to comprise a Water Scheme under the Water Act 1989 and a Special Charge Scheme under the Local Government Act 1989.

The process has identified that a very low level of landowner support exists for the project. Council can now consider the response and resolve whether to proceed to further develop the scheme or to take alternative action to assist the Community.

RECOMMENDATION

That Council:

- 1. Not proceed with the process of development of a Water Scheme and Special Charge Scheme for Violet Town; and
- 2. As an alternative, utilising the available flood data and information received from the Community
 - a. Undertake a review of Council's strategic planning controls to ensure that an appropriate zoning or overlay is placed on flood prone land, and
 - b. Investigate the upgrade of the township drainage system to achieve improved flood resilience where possible.

Background

Community Update Meeting - 6th July 2016

Glen Ryan, (GMR Engineering), presented a detailed summary of past and present flood mitigation design for Violet Town.



5.7.3 Violet Town Flood Mitigation Project (cont.)

Steve Muncaster, (Manager, Floodplain Management, DELWP), presented the funding opportunity provided by the new Victorian Floodplain Management Strategy. He indicated strong support for this project.

The Director, Asset Services, presented the process of landowner consultation for the Water Management Scheme, as well as the proposed Special Charge Scheme.

Letter mailed to 235 landowners, 11th July 2016. All of the materials included at the meeting were enclosed. Confidential questionnaires, prepared to gauge the level of support from landowners in categories -

- Those receiving a Special Benefit to be included in the Special Charge Scheme (136)
- Those receiving no Special Benefit, not included in the Special Charge Scheme (30)
- Those receiving an adverse effect, not included in the Special Charge Scheme (4)
- Those not specifically affected, not included in the Special Charge Scheme (65)

were included, returnable by 29th July 2016. In response to a letter from Violet Town Action Group, the date was extended to 3rd August 2016.

The level of support from landowners to receive Special Benefit was 9 out of 136 or 6.6%.

Alternative options

Council has the option of not proceeding with the proposal. The flood data obtained in preparing the proposal can be utilized to strengthen statutory planning controls for the benefit of the community.

Some of the responses received from the community indicate that investigation into drainage improvements may be worthwhile.

The author of this report considers that the recommendation has no legal or statutory implications which require the consideration of Council. Council has no statutory duty to prevent flooding.

Council has an ability to assist a community in the development of a Water Scheme and can develop a Special Charge Scheme to fund a Water Scheme, but in this case it is apparent that adequate support for Council's involvement does not exist.

The current level of support from landowners who might be involved in the Special Charge Scheme (6.6%) appears problematic.

Ultimately, the Local Government Act 1989, specifically prohibits a Council from making any Special Charge declaration where objections comprise a majority.

With such a low level of support, Council could, if it proceeds further, expect to face VCAT challenges to any scheme.
