Summary

Nacap Australia Pty Ltd is proposing to implement a series of short term local road closures to enable the safe construction of the gas pipeline across local roads or road reserves.

RECOMMENDATION

That Council delegate to the Chief Executive Officer and to the Director Asset Services the power to approve road closures as necessary for the gas pipeline project in accordance with the Local Government Act 1989 schedule 11, clause 10 "Power to place obstruction or barriers on a road temporarily".

Background

- Nacap has taken out a "Works Within Road Reserves" permit covering all municipal roads impacted by the pipeline works. The permit runs from 18/10/2014 until 01/04/2015 and covers "Pipeline construction/installation through carriage way, tree trimming/clearing within road reserve, potholing within road reserve, and fencing installation within road reserve."
- The new request relates to those municipal roads which are trafficked. The roads are listed on the attachment with an indicative construction date.
- Agreement has been reached with Nacap on implementing the closures:
 - → Nacap will advise Council of the subject road (or section or road) and date(s)/period of closure (to enable Council to respond to any public enquiries);
 - → Nacap will contact the landholders/occupants along the subject road (or section of road) to advise details of the planned closure and discuss any concerns those already known to Nacap (chiefly those located along the pipeline easement) would be contacted by phone or in person, while other landholder/occupants situated along or with accesses off the subject road (or section of road) would be contacted by door knocking or if unsuccessful by letterbox drop (including details for Nacap's Lands Liaison Officer);

5.7.1 <u>Gas Pipeline Construction – Short Term Local Road Closures (cont.)</u>

- → Signs will be erected on the nearest intersections to the planned closure site, at least 24 hours prior, giving road users advance notice of the closure and the dates/times involved; and
- → On the days(s) of the closures appropriate signage will be in place at the intersection(s) leading to the closed section of road (such as "Road Closed XX Metres Ahead, Local Traffic Only", and other advisory and warning/safety signs installed, as per the applicable Traffic Management Plan.
- Alternative routes or access arrangements will be available for intending users of all these roads,
- The length of these closures will be either 24 or 48 hours, depending on road type and construction conditions. All closures would be undertaken in a manner consistent with the Traffic Management Plans submitted with the "Works within Road Reserves" permit.

Alternative Options

Nacap's approach to the closures is well thought out, and considerate of the road users and Council. Options are neither available nor required.
