CONDUCT OF PUBLIC

- 52. VISITORS
 - (1) Visitors must not interject or take part in debate.
 - (2) Silence shall be preserved in the gallery at all times.
 - (3) If any visitor is called to order by the Chairperson and again acts in breach of this Local Law, the Chairperson may order that person to be removed from the gallery.

53. CALL TO ORDER

Any person who has been called to order, including any Councillor who fails to comply with the Chairperson's direction, will be guilty of an offence.

Penalty: \$500

54. REMOVAL FOR DISRUPTION

The Chairperson has discretion to cause the removal of any person, including a Councillor, who disrupts any meeting or fails to comply with a direction under the provisions of this Local Law.

Summary

Section 125 of the Local Government Act 1989 (the Act) states that:

- (1) A Council must prepare and approve a Council Plan within the period of 6 months after each general election or by the next 30 June, whichever is later.
- (2) A Council Plan must include
 - (a) the strategic objectives of the Council;
 - (b) strategies for achieving the objectives for at least the next 4 years;
 - (c) strategic indicators for monitoring the achievement of the objectives;
 - (d) a Strategic Resource Plan containing the matters specified in section 126;
 - (e) any other matters which are prescribed by the regulations.

Therefore, in accordance with the *Act*, Council has developed its Draft Council Plan for 2013–2017 ready for community consultation. This new Plan sets out the objectives and strategies that Council, on behalf of the Strathbogie Shire community, is committed to delivering over the four years ending 30 June 2017.

The draft Council Plan has now been prepared and is available to the public for review and comment / submissions. Copies of the document will be available for inspection at the following locations from Wednesday 15 May 2013:-

Any person has a right to make a submission under Section 223 of the Local Government Act 1989 on the proposed Council Plan Persons wishing to be heard in support of their submissions must so indicate in their written submission.

A Special Meeting of Council will be held at the Euroa Community Conference Centre on Thursday 20 June 2013 commencing at 5.00 p.m. to receive written submissions and for persons wishing to be heard in support of their submission.

A copy of the Draft 2013-2017 Shire of Strathbogie Council Plan, which includes the Strategic Resource Plan, has been distributed to Councillors for their information. Copies of the documents are tabled for identification purposes, and are Appended to the Agenda for the meeting.

These new Plans set out the objectives and strategies that Council, on behalf of the Strathbogie Shire community, is committed to delivering over the four years ending 30 June 2017. Council's Draft Strategic Resource Plan is based on the previous Council's Long Term Financial Plan and is currently being reviewed as part of the consideration for the draft 2013-2014 Budget.

The Council Plan is a strategic document of Council that sets its Vision / Mission / Goals and Objectives for the (4) four year term of the Council. The Actions that sit under each Goal ensure the organisation delivers what the Council has set as its long term strategic vision for its community.

The program dates for this Draft 2013–2017 Council Plan are as follows:

- 1. Adopt the Draft 2013–2017 Council for Public Exhibition 7 May 2013
- 2. Public Exhibition period closes at 5pm Wednesday 12 Thursday 13 June 2013
- 3. Councillor Briefing on Public Submissions Monday 17 June 2013
- Submissions Hearing to receive/hear submissions on the Draft 2013–2017
 Council Plan Thursday 20 June 2013
- 5. Special Council Meeting to adopt 2013–2017 Council Plan Wednesday 26 June 2013
- 6. Present adopted 2013–2017 Council Plan to the Minister for Local Government by Friday 28 June 2013.
