



NO.1

We would like to place a monument on the north end of the median strip, opposite the Museum Building, with a plaque recognising the former Goulburn Shire, which met in the building from 1887 until 1969. A monument was actually approved when Gregory Carlson was Mayor in the 2000's but it has never been acted upon.

We would propose that the monument recognises not only the Goulburn Shire but also the Goulburn Weir on the other side. Attached is a photo of the proposed monument, which will receive some private funding. The granite stones have actually been sourced from the Weir site.

Picnic tables could be placed amongst the trees already growing in the median strip and this would extend the tourist area of the town to the north, especially if a roundabout is to be constructed at the northern entrance to the town (ie. Vale Street). This area under the current drafts does not get enough exposure. Also there would need to be a water supply of some description.

Another item we would like considered is to have recognition of the 2 Stawell Gift winners who were born, trained and were living in Nagambie District at the time of winning this prestigeous foot race. Ideally this could be put on the signage on each end of the town. Their medals and other memorabillia are displayed in the Nagambie Museum.

NO.3


The High Street design is said to focus on key landmarks like the water tower, cenotaph, old mill and the median strip. The design does not mention any buildings in the north end of the town. The Royal Mail Hotel (1871) complex, including the Nagambie Historical Society building (Museum), are actually the oldest historical buildings remaining in Nagambie.

These were built by Cr. William Sheehan. The Nagambie Historical Society building (Museum) was also the Post and Telegrah office until 1887, the Court of Petty Sessions and the Shire of Goulburn offices from 1888.

We feel that any streetscape design should extend to, and enhance, this northern area of the township of Nagambie.




