1. What changes in Strathbogie Shire do you like? Long Text | Skipped: 5 | Answered: 8 (61.5%)

4608	Regarding Avenel, I like how the SSC communicate with residents and seek feedback, such as this survey. We gave feedback to the Streetscape Project planning and have been fortunate to receive funding for a feasibility study towards improving the Bank Street/Saleyard Road parking area next to the railway. Recently the Planners were personally available to answer questions from the community which is always helpful for people to feel consulted. (Even though they may not always like the outcomes!)
4561	Towns are expanding due to recent popularity of regional areas for lifestyle and affordability reasons.
4540	Strategic planning has allowed new residential zones to be developed. The livelihood of regional towns depends on sustainable growth in the number and diversity of residences.
4505	 Tree planting - and gardening. I think more investment is needed in green space in our community. Dog park and a great opportunity to plant trees around the perimeter of the dog park. Development of Binney Street is a great start! I hope pedestrian crossings will be installed also. I can't wait to see the end result. Very excited. Instillation of new bridge at rockies. Compliant / safe and preserves natural river system.
4487	Very excited to see (and feel) the Binney St greening, microclimate enhancement is very necessary.
4481	After talking to Braydon and Daniel we were heartened that the shire has finally worked out there is a thing called climate change and any future developments need to take this into account big time!!
4384	Would love more trees in the streets of Nagambie. It would help Nagambie not look so Baron and It is also so hot walking around town with kids and no doubt the Elderly too. Completed footpaths. There should be a footpath down church st to access GP/nursing home. I often see elderly on scooters riding along roads
4374	Development on the main streets. Getting rid of old service stations and vacant blocks.




4639	Too many new houses being built in Avenel and surrounds. Not enough parking for all pending new residents, in centre of town, viz. Queen St.
4608	Re Avenel: The increased housing development is predictable but I wonder how this will affect movement around the town? Everyone will need to use their cars to do anything - shopping, medical appointments, visit friends, etc. The arterial roads which carry all traffic including heavy vehicles, create safety issues for pedestrians and drivers. Crowded parking, U-turns and poor visibility in Queen Street are classic examples. Further increase of local traffic will make this worse. We need a town business centre which would help separate through traffic from local traffic and potentially cater for a supermarket. Not easy. Except for those who ride bicycles or like walking, we are developing a town which will be totally reliant on motor transport to go anywhere, given the only public transport (train) is limited. At least two cars per household, this will increase the local traffic significantly.
4561	It is not appropriate to transfer to the shire's towns the General Residential Zone designed to suit Melbourne suburbs without proper protection of the existing neighbourhood character.
4540	The General Residential Zone was designed for Melbourne's suburbs, and is not usually compatible with the neighbourhood character of the shire's towns. If applied with no schedules to suit individual towns, new subdivisions have the potential to become bulky and dense, affecting the 'country feel' identified in Clause 21.03–7.
4509	The 2022 Avenel Community survey identified that the highest prioirty is that Avenel maintains its rural village character, yet we don't walk the talk. 1. Tree removal. Significant old growth native trees and some introduced species (eg pepper tree) have recently been removed from private property. We risk become a moon-scape! Cut by cut our rural village is being cut down. Impact on our climate. Impact on the 'look and feel'. Loss of historical. 2. Inappropriate subdivision. Some blocks in Anderson Street have been subdivided into extremely small, suburban size blocks. Why and how? 3. Historical protection: without overlays or similar we are losing the historical fabric of one of Victoria's earliest goldrush service towns. Apart from the State Heritage listed bridge and former Royal Mail Hotel there are no heritage guidelines that owners must meet. The early Shire heritage study was not endorsed, and since then we have lost some of the early fabric of our village. Many buildings and some trees need urgent protection, including an 1852 brick urinal of the Imperial Hotel, an 1860s slab/plaster hut on the corner of Wedge and Scobie Sts, an 1854 planted Morus Nigra tree at 42 Mitchell St and a row of osage trees at 34 Livingston St planted at the early 1860s schoolhouse (Ned Kelly connection), an Aboriginal scar tree off Mutton St.
4505	- Nothing in particular. I like change.
4487	The majority of houses that are being built across our Shire are still based on 1950's house styles.
4481	Overcrowding of houses/buildings on small rural blocks putting future pressure on flood overlays and turning our small country towns into replicas of Melbourne and creating the social ghettos of the future with all the problems that come with that! Think about the legacy and don't do things that create future litigation (as will happen) when you have been warned about all the environmental and social problems that will follow. All these issues are foreseeable. Allowing people to dump relocatable houses, that are not only people's 'trash' houses at times, making us look like a US mid-west trailer park, that are never fixed and only make poor people who are expected to rent them, look poor! It is socially unacceptable and not good enough.
4475	New housing developments that have VERY NARROW roads eg. the various courts off White St Euroa have roads so narrow that a car parked on either side means a vehicle can't get through - let alone what would happen in an emergency, with narrow access for ambulance and fire trucks. A one way in, one way out approach is not safe.



	I'm concerned about the environmental requirements. There should be no extra local requirements.
4471	There should be less restrictions on heritage issues. Over protection of old buildings can destroy them - Shepparton Hotel facade for example.
	More small holdings should be available. Rural residential style
4384	Please do not allow more Horse statues in front of lake Nagambie. Horses are a hobby/interest for a very small group of people, I personally have no interest at looking at them. It would look tacky. Have horse statues at the entrance of all of the horse farms and create a horse farm self drive tour.
4374	Too many restrictions

4639	Mandate an alternative truck route AROUND Avenel , in order to prevent their use of Queen and Bank ST. EAST[between Queen St. and Vearings Rd.]
4608	Volunteer groups already participate in this process in Avenel and availably of grants to assist this is much appreciated.
	Through Schedules to the General Residential Zone.
4561	For Violet Town, in particular, there are two strategic planning documents from July 2010 that have never been enshrined in the planning scheme - 'Violet Town Neighbourhood Character Study' and 'Violet Town and District Strategic Management Plan'.
4540	Identify the important elements through a Neighbourhood Character Study in order to develop planning controls such as town-specific schedules to the General Residential Zone.
	Shire support or nominate listing significant Avenel heritage sites with Heritage Victoria.
4509	Implement the Shire heritage study that was conducted in the past (centred on the new railway era town) and commission one that identifies the significance of the surviving goldrush-era service town.
	Heritage overlays in planning documents for Avenel.
4505	 Maintaining old building and assist owners on these directions. Paint is a good base for improving aesthetic. Back of businesses are very exposed and unattractive Abandoned business buildings in neighborhoods are not acceptable - someone is responsible. Owners should be given orders.
4481	Don't cut down old heritage trees because some fool tells you they are not native. They ARE a valuable and irreplaceable part of our colonial heritage which is just as important as anyone else's culture and heritage. They are also environmentally valuable in absorbing heat in the summer to cool blocks and houses and add to the beauty of our neighbourhood. Protect them - don't destroy them!



4639	Refuse permits for any industry , and, or, more houses to be built, PLEASE
4608	As a member of Avenel Active, we do its best to work towards the community's interests but we are predominately senior citizens. What would be helpful would be if there could be some assistance, to do what I call "break down the silos", to encourage more interaction between age groups so we can all work together for what is best for the future of the town.
4561	The Violet Town documents became 'policy' in 2010 and yet are still not reflected in the shire's planning scheme despite the scheme having to be reviewed every four years. They contain valuable objectives and strategies that should be used to manage the likely increase in subdivision approvals so that neighbourhood character is respected as required in Clause 32.08. Town-specific schedules to this clause would help manage this planning aspect into the future.
4540	Ongoing community engagement.
4509	Identify and list historically significant buildings and landscape before it disapears. No political decision about what the backlash might be. Create a small grant funding opportunity for small heritage grants to owners of listed properties (local significance).
4505	 Take the community on the journey and highlight the benefits of change for the community. I think the cinema is a great resource to explain changes to the community. Perhaps via short film at the start of a movie that can also be shared via other social media. Instillations in vacant shops to help community to understand and accept change. I think we all need to understand and articulate changes much better - what these changes actually mean for the community.
4487	Consider * single person dwellings (even tiny houses for people who want to radically downsize) * environmentally sustainable community housing projects * 'adaption' sessions for making the current established house stock more efficient. * an increase in residences within the shopping precinct of Binney St and other towns commercial centres. (Adds to security, lessens dead night zone feel, more designed density, less suburban sprawl)
4481	Understand the needs and wants of the current community! Greed for more rates money is NOT an acceptable way to engage with a community who live in small country towns for a reason. If we wanted to live in crowded suburbs, we would! Respect the community views and values before making decisions that leave us with the problems when all the decision-makers go home!
4471	Less restrictions. No environmental/green requirements above or beyond what is required by state legislation.

1. What changes in Strathbogie Shire do you like? Long Text | Skipped: 5 | Answered: 7 (58.3%)

4656	I like the stated focus on climate change
4568	Enforcement to prevent vegetation clearing of roadside vegetation, especially that under the green, high habitat quality listings, which is cleared at ground level of vegetation and debris (which = wildlife habitat lost), plus illegal firewood take. Follow up on reporting of such activity. (See my 20/7/22 submission to info@strathbogie.vic.gov)
4558	Some years ago the Euroa Memorial Oval initiated a planting of local native plants (grasses, wattles, lomandras, busaria, correas, daisies etc) along the creek-facing embankment replacing the invasive periwinkle weed. With some weeding and more plants, this planting has thrived and not long ago Gang Gang cockatoos were observed enjoying the wattle seeds. Gang Gang cockatoos are familiar visitors to Euroa but are now on the endangered species list. This could be seen as indication of the vital role Strathbogie Shire can play in regeneration and restoration of existing natural assets to provide habitat and biodiversity to support native wildlife and further enhance the natural beauty of our region.
4507	- Greening Euroa. Great initiative that will support new growth of vegetative spaces.
4382	The planting of local indigenous plants including ground covers, grasses, flowers, shrubs and trees.
4379	None
4284	Retention of old trees,



4656	I'm concerned about the lack of change, I think alot of the unfarmable, important bushland needs to be rezoned so that when it is developed the shire can have some say over whether the use of the land is appropriate and any dwellings are built with low impact
4564	Removal of native trees in new residential subdivisions without requiring a planning permit. Under the General Residential Zone there is no inbuilt protection when land is subdivided into individual residential lots. Trees are 'deemed' to be lost. This is not protecting the 'natural beauty' described above.
4558	Developments such as Eloura at Nagambie. The unique grove of yellow box, grey box and red gum so close to the town that has the makings of a superb natural parkland. Also concerned at the development of Serenity between the Arboretum and the Town, especially as it is low lying and near a creek.
4507	- i'm concerned that people will push for removal if roadside trees in the shire.
4494	ALL of our beautiful trees will be under stress from the climate emergency, so start trimming Mistletoe?
4483	If the above statement is true, then DON'T ALLOW 20 houses to go on one small block in Violet Town as it will create every conceivable environmental disaster and leave our future generations with a ghetto!
4474	Don't limit housing and development in favour of trees. People should not be short of homes while trees take up the residential space.
	Farms should be able to clear land for farming.
4382	I am involved with Shadforth Reserve Committee in Violet Town. More introduced weeds are growing throughout the reserve. These need to be reduced.
4379	Too much emphasis on environmental ideals. I am concerned that the public has too much influence on what happens to private land.




3. What ideas do you have for encouraging future development, while protecting vegetation? Long Text | Skipped: 3 | Answered: 9 (75%)

4656	Please look at expanding the zoning to include rural conservation zoning and rural living zoning. Instead of just farming and residential. This would allow more scrutiny of dwellings and increased focus on conservation of land that is not suitable to agriculture but is in farming zone, and allow people to live there without needing to run stock or produce to meet farmzone requirements. This is already in the planning scheme of Victoria.	
4564	Build in a planning control through a Schedule to the planning scheme that protects all existing native vegetatio This may mean that some blocks in a new subdivision have to be larger to cater for an adequate protection zon around native vegetation.	
4558	The Shire of Strathbogie has a wealth of natural assets to maintain and conserve and it is a huge responsibility for a small local government entity so working in partnership with community agencies and groups and individuals and tapping into their local knowledge and expertise is important. Eg The Strathbogie Forests. Euroa is fortunate to have a remarkable natural asset in its creek that runs through the town and can be accessed by all with its walking track. There are now patches of restored vegetation - it is a very long term vision to eradicate exotic weeds, to regenerate and restore and maintain but I think it is important to have this vision for the Seven Creeks in Euroa as it is what the recently released State of Environment Report is clearly advocating. we need to do for the protection of wildlife and to combat the challenges of climate change.	
4494	Give every resident, business owner & organisation one tree to plant in their garden this may inspire other greening ideas. Guide & permit shop owners to grow appropriate creepers on their shop facades to help shade and cool the terrible walking surface (Binney St, Euroa) this would enhance the shopping experience for locals & visitors.	
4489	Only support truely environmental projects, green industries (we could be a hub!)	
4474	Plant more on public land. Encourage don't legislate. Balance fire protection with the need for vegetation	
4382	Specifically to Shadforth Reserve, reduction of introduced weeds by use of cool burns, using first nation peoples methods. Usage of cameras with night spotting ability, to observe animals feeding on plants to understand which plants benefit the Australian wildlife. Cameras can also detect introduced animals (such as deer), indicating which plants need protection from invasive animals.	
4379	Only ever planting non-native species so that they can be removed or replaced without the shires interference. The shire should encourage development not hinder it	
4284	Allow urban land owners with Urban Flood Zone to get a rate reduction for this area of land and provide urban land holders with grants to landscape their UFO to support native vegetation. Make it a benefit to own a property with this designation.
