As stated in the *Domestic Animals Act 1994*, animal owners may receive a concession as defined in the *State Concessions Act 2004*. Animal owners must read and sign the declaration below.

I...... authorise:

- Strathbogie Shire Council to use Centrelink Confirmation eServices to perform a Centrelink/DVA enquiry of my Centrelink or Department of Veterans' Affairs customer details and concession card status to enable the business to determine if I qualify for a concession, rebate or service.
- the Australian Government Department of Human Services (the department) to provide the results of that enquiry to Strathbogie Shire Council

I understand that:

- the department will disclose personal information to Strathbogie Shire Council including my name, address, payment and concession card type and status to confirm my eligibility for concession.
- this consent, once signed, remains valid while I am a customer of Strathbogie Shire Council unless I withdraw it by contacting Strathbogie Shire Council or the department.
- I can get proof of my circumstances/details from the department and provide it to Strathbogie Shire Council so my eligibility for concession can be determined.
- if I withdraw my consent or do not alternatively provide proof of my circumstances/details, I may not be eligible for the concession provided by Strathbogie Shire Council.
