## 3: Regional context of noxious weed and pest animal management:

The Strathbogie Shire Council is located in the northeast of Victoria and covers approximately 1,111 square kilometres. The landform consists of sparsely treed granite hills and fertile river flats. The area is predominantly rural and includes large production farms down to small hobby farms, weekenders owned by Melbourne residents or unoccupied bushland protected under Crown or Covenant. There are also low density settlements surrounding the rural townships of Violet Town, Strathbogie, Ruffy, Avenel and Longwood and urban settlements in the major regional centres of Euroa and Nagambie.

Strathbogie Shire Council is responsible for the management of approximately 3,000kms of local road network and is dedicated to managing weed infestations on council managed land and committed to the early prevention and control of weed species newly identified in the area.

## 4: Community Consultation:

Council works closely with our 11 Landcare Groups to implement the Roadside Weed and Pest Program, holding regular meetings with all groups to receive and give updates, troubleshoot issues, run and participate in workshops and support landowners in their sustainable faming and noxious pest eradication endeavours. The Landcare Groups will also be engaged as part of the development of the plan.

## 7: Objectives of the Plan:

To contribute the Shire's ongoing roadside weed and rabbit management program and to complement past works that have been completed by Strathbogie Shire, various Landcare groups and the State Government. Assist with the preventing the spread and introduction of invasive plant and animal species across the Shire and the region as a whole.

Strathbogie Shire Council's overall roadside weed and rabbit management objective is the effective and proactive management of invasives species on Council managed roadsides across the Shire. Investment of grant funds will be aligned to:

- 1. Treatment for the eradication of Regionally Prohibited Weed infestations
- 2. Treatment for the containment or reduction in area infestations of Regionally Controlled Weeds and pests, particularly where these align to projects being undertaken by other organisations (ie Landcare, DoT)
- 3. Supporting community group investment in declared weed and pest control projects
- 4. Contributing to other previous investment in the control of Regionally Controlled and Regionally Prohibited Weeds and pests
- . 5. Protect identified assets such as significant roadside vegetation under threat from weed invasion or other significant roadside infrastructure
  - 6. Support weed and pest animal management projects being undertaken by land owners
  - 7. Addressing other roadside declared noxious weed infestations of concern to the Shire's community including Restricted Weeds declared under the Catchment and Land Protection Act 1994 (CaLP Act 1994)

## 8: Term of the Plan:

The plan will run for a maximum three year period to 30 June 2026.
