# 9.2.1 <u>Event Grant Applications Received</u> - Avenel Active Inc and Nagambie Lakes Sailing Club

### **EXECUTIVE SUMMARY**

Council adopted a community funding model at the June 2023 Council Meeting. This model sets out the strategic direction and associated guidelines for the distribution of community funding for Strathbogie Shire Council. Event Grants provide grants of up to \$5,000 to eligible organisations and associations for events that align with the objectives of the Council Plan 2021-25, submitted in line with Council's Event Guidelines.

Council has received two (2) Event Grant applications for Council's consideration.

An application was received from Avenel Active Inc to support the delivery of the Nagambie Lake Parkrun commencing from Saturday 6 April 2024, and each Saturday thereafter. The Nagambie Lake Parkrun covers a 5km course every Saturday morning along the newly installed Nagambie Boardwalk, enabling Nagambie, Avenel and regional residents and visitors to participate in exercise in a safe, natural environment. Avenel Active Inc have applied for a total of \$5,000, to cover the cost of licensing and equipment.

An application was also received from Nagambie Lakes Sailing Club Inc to support the delivery of Sailing activities during the Nagambie On Water Festival (NOW) 2024 being held on 24 February 2024. The Nagambie Lakes Sailing Club Inc. will host a sailing event as part of the Festival which will include coaching sessions for club members and sailing opportunities for the public. Sessions will be facilitated by Australian Sailing – Smooth Sailing School as well as the Shepparton Sailability Club. This event will be followed by a series of events throughout March 2024 for the public to enjoy that promote sailing and recreation. The funds have been requested to cover the cost of facilitation and delivery by Australian Sailing.

Both events will result in several significant social and economic benefits to the Strathbogie Shire community and will be delivered in line with Council's Events and Regulatory policies and procedures.

Council has a budget of \$50,000 allocated to Event Grants under the Community Funding Model in the 2023/2024 Budget. Applications have been submitted in line with the Event Grant Guidelines 2023-24 adopted on 20 June 2023 and have been assessed in accordance with the relevant assessment process. The current applications are of an acceptable standard and officers are recommending them for funding.

### RECOMMENDATION

- 3. Work with both event organisers, as a condition of funding, to reduce overall waste produced at the event through the implementation of the objectives of both the Waste Wise Events Guidelines and Sustainable Strathbogie 2030 in being "A Zero Waste Shire".

# **PURPOSE AND BACKGROUND**

Council adopted a community funding model at the 20 June 2023 Council Meeting. This model sets out the strategic direction and associated guidelines for the distribution of community funding for Strathbogie Shire Council.

Council recognises the importance of events and tourism to the social and economic growth of our region. Furthermore, Council has a strong history of supporting and delivering events across the Shire. This is demonstrated by an investment in events through Council's Event Grants.

Event Grants provide grants of up to \$5,000 to eligible organisations and associations for events that align with the objectives of the Council Plan 2021-25.

Council has received two Event Grant applications for Council's consideration, detailed below in Table 1.

# ISSUES, OPTIONS AND DISCUSSION

One of the overarching governance principles in section 9 of the *Local Government Act 2020* is that priority is to be given to achieving the best outcomes for the municipal community, including future generations.

Council adopted a community funding model at the June 2023 Council meeting. This model sets out the strategic direction and associated guidelines for the distribution of community funding for Strathbogie Shire Council. Event Grants provide grants of up to \$5,000 to eligible organisations and associations for events that align with the objectives of the Council Plan 2021-25, submitted in line with Council's Event Guidelines.

Council has received two (2) Event grant applications for Council's consideration.

# Nagambie Lake Parkrun

Nagambie Lake Parkrun is a free, community event where you can walk, jog, run, volunteer or spectate. Parkrun offers a course that is 5km long and takes place every Saturday morning. The proposed course will run from Buckley Park to the Regatta Centre and back. Parkrun events pride themselves in being positive, welcoming and inclusive, there is no time limit and no one finishes last. Everyone is welcome.

There are currently 486 parkrun events around the country, including a well-established one in Euroa. Once a participant is registered with parkrun, participants can attend any event across the nation.

The funds have been requested to help cover the costs of Parkrun Australia licensing and associated equipment. GoNagambie and other community partners are also supporting the introduction of this regular community event.

# Sailing at Nagambie On Water Festival 2024

The Nagambie Lakes Sailing club Inc. will host a sailing event as part of the Nagambie On Water (NOW) Festival on the 24 February 2024. The club will engage Australian Sailing - Smooth Sailing School, to conduct sailing coaching for club members and sails for the public in multi seater Pacer yachts. The Shepparton Sailability Club will also conduct sailing coaching for members and sails for the public in two-seater Hansa Access sail boats. The club aims to also provide weekly sailing experiences for members and the public during March 2024 to promote recreation and physical health and wellbeing. The funds have been requested to cover the cost of facilitation and delivery by Australian Sailing.

The two (2) applications submitted have been assessed as eligible in line with the relevant evaluation process and officers recommend them both for funding to the value requested in their respective applications.

Both events will result in social, and health and wellbeing benefits to the Strathbogie Shire Community and will be delivered in accordance with Council's Events and Regulatory policies and procedures.

As part of the conditions for funding, the event organisers must obtain Event Approval from Strathbogie Shire Council and deliver zero waste events. All required documentation including, risk plans, and public liability insurance will be provided.

### SUSTAINABILITY CONSIDERATIONS

One of the overarching governance principles in section 9 of the *Local Government Act 2020* is that the economic, social and environmental sustainability of the municipal district, including mitigation and planning for climate change risks, is to be promoted.

### **Economic**

Both events will result in several economic benefits to the Strathbogie Shire community, attracting members from the region to participate in these events. All items relating to the event will be sourced locally, where possible, and several vendors will be sourced from the local community.

# <u>Social</u>

The events will offer significant social benefits to the local community and those attending the event. The event provides an opportunity for participants, community, and visitors alike to connect, re-engage and explore the local area, share interests, sports and hobbies and make lasting relationships. Both events will be delivered through volunteer groups and associations, groups like these add significant social capital to the local community and for a key aspect of community life. The benefits of volunteering have been well documented, and include improved health and wellbeing, social connection, improved skills, capacity and employability.

There is also significant Health and Wellbeing outcomes for participants associated with the activities in both these applications.

# **Environmental**

Council officers will work with both event organisers to support the delivery of the events and reduce the overall waste produced at the events through the implementation of the objectives of both the Waste Wise Events Guidelines and Sustainable Strathbogie 2030 in being "A Zero Waste Shire".

# Climate change

Officers will work with event organisers to implement initiatives as a part of the Waste Wise Events Guidelines, showcasing how a waste wise event should be run and encouraging all to reduce their consumption of raw materials in a further effort to reduce the effects of climate change.

### **CONCLUSION**

It is recommended that Council approve both event funding applications, to the values requested by the respective applicants.

These events will result in significant economic and social benefits to the community and the broader region, aligning with the objectives of the Council Plan 2021-2025 and Council's adopted Community Funding Model.

# 9.3.1 <u>Tender for Contract No. 23/24-26: Consultant to Provide Detailed Options and Design – Civic Accommodation and Outdoor Operations</u>

#### **EXECUTIVE SUMMARY**

The Strathbogie Shire Council recognises the imperative to enhance its civic presence and administrative capabilities to meet the evolving needs of the community. The existing Euroa-based civic office and operational depots are deemed inadequate in poor condition with water entering office during rain events at many locations, necessitating a comprehensive study to explore contemporary alternatives. This project aims to conduct a feasibility study to assess options for a renewed civic presence that aligns with the community's changing demographics and ensures efficient service delivery.

The project scope encompasses a thorough examination of the existing Euroa Civic Centre, the library service in Nagambie, operational depots in Euroa and Nagambie, and smaller satellite sites in Avenel, Violet Town and Strathbogie. The study aims to deliver location options and preliminary designs with indicative costing for civic office accommodations and outdoor operations hubs, considering the unique needs of the community and stakeholders. These deliverables will guide Council in making informed decisions for future development, ensuring alignment with community needs and preferences.

It is crucial to note that any subsequent works resulting from this feasibility study are contingent on securing funding and grant applications. Council acknowledges the growing population in Avenel and Nagambie, signalling the timeliness of addressing the inadequacies of the current facilities to better serve the community, shire, and stakeholders.

Through public advertisement in local and state newspapers, Council invited tenders for the work under Contract No. 23/24-26, between 03/11/2023 and 06/12/2023. At the closing of the Tender, eight (8) tender submissions received. These tenders have been assessed and evaluated by Council Officers and a summary of results is detailed in this report.

It is recommended that the Council awards this lump sum contract to Workshop Architecture Pty Ltd based in Melbourne, for a total amount of \$183,755.00 (including GST).

# **PURPOSE AND BACKGROUND**

Strathbogie Shire Council recognises the imperative to adapt to the evolving needs of its community in response to changing demographics and requirements. The current civic building in Euroa is no longer fit for purpose and the recent storm events leading to water damage highlight this need.

Considering this, Council has undertaken a commitment to explore and analyse potential avenues for the development of a revitalized civic presence.

This initiative aims to enhance administrative functions, including those related to Councillor activities, provide appropriate office amenities to the staff providing Council services and optimise outdoor operations. The current facilities, namely the Euroa based civic office accommodation and two operational depots, have become inadequate and no longer serve their intended purposes. The feasibility study will also consider the needs of the Nagambie Library to support long term service delivery.

# **Tender Process**

The public tender was released on <a href="https://www.eprocure.com.au/strathbogie/">https://www.eprocure.com.au/strathbogie/</a> website on the 03/11/2023. The tender was advertised in Saturday's The Age newspaper (state-wide reach), and Shepparton News in the week following release. By the close of tenders at 4.00pm on 06/12/2023, eight (8) tender submissions had been received.

Table 1 below lists the tenders that were received at the close of the advertised tender period.

Following an evaluation of all tender submissions, a comprehensive assessment was conducted to ascertain compliance with contractual terms, conditions, and the stipulated response schedules. Among the eight (8) submissions scrutinized, four (4) were identified as non-conforming. The non-compliance was based on a deviation from the specified tender requirements, coupled with a demonstrated lack of understanding regarding the project's scope and deliverables.

This deficiency in compliance is further underscored by an analysis of their pricing submissions, revealing that the aforementioned four (4) submissions presented the lowest pricing among all submissions. This notable trend was also a factor in the collective decision of the tender assessment panel during the tender moderation. Consequently, to uphold the integrity and fairness of the tender process, the comprehensive assessment process was undertaken on the four (4) conforming tender submissions.

# **Panel Assessment Process**

In accordance with Council's Procurement Policy, the evaluation panel and evaluation criteria weightings were determined prior to release of the Tender documentation. The evaluation panel members were nominated prior to release of the tender submissions for evaluation. The panel signed 'Conflict of Interest' statements prior to the evaluation panel viewing the submitted tenders.

The Tender Evaluation Panel members were made up of the following Strathbogie Shire Council officers as follows:

- 1. Manager, Project Delivery Sustainable Infrastructure
- 2. Senior Project Officer, Project Delivery Sustainable Infrastructure
- 3. Principal Property Officer, Project Delivery Sustainable Infrastructure
- 4. Procurement & Tender Officer, People and Governance (moderating).

The principle that underlies the awarding of all Council contracts is that a contract is awarded based on providing the overall Best Value, offering the most benefit to the community and the greatest advantage to Council.

The tenders were assessed and evaluated against the following criteria and weightings in line with the Council Procurement Policy:

# ISSUES, OPTIONS AND DISCUSSION

#### **Evaluation Moderation Process**

The purpose of the moderation meeting is to discuss and moderate scoring discrepancies larger than three points and to raise any concerns and/or queries that may need to be put to the tenderers prior to recommending the preferred Tenderer.

The Tender Evaluation Panel individually reviewed all tender submissions in detail and assessed tenderers submitted schedules and attachments against the evaluation criteria.

The Moderator (Procurement & Tender Officer) averaged the scores and highlighted scoring discrepancies larger than three (3) points. On Monday 11 December 2023, the Panel members and the Moderator met to finalise the evaluation through a moderation meeting.

# **Panel Assessment Summary**

One of the overarching governance principles in section 9 of the *Local Government Act 2020* is that Priority is to be given to achieving the best outcomes for the municipal community, including future generations.

At the completion of the tender evaluation process, Workshop Architecture Pty Ltd attained the highest ranking with a total score of 87.01%. Their collective experience extends across collaborations with regional Councils, government bodies, and private entities, as evidenced in their detailed submission. Moreover, their submission underscores a distinct capability to execute the tendered works with minimal oversight, reflecting a high level of self-sufficiency and competence in adhering to project specifications.

### **EXECUTIVE SUMMARY**

Strathbogie Shire is committed to managing local transport infrastructure, ensuring safe and efficient access to the road network for the broader community within the municipality, maintaining a consistent standard.

The Nagambie Locksley Road Bridge over Charles Creek, situated approximately 12km from Nagambie, is currently inadequate and unsuitable for present and future road usage due to insufficient load capacity. Safety concerns are exacerbated by a compromised road alignment, impacting visibility and the overall speed environment.

During 2022 and 2023, a comprehensive assessment of requirements, along with detailed design considerations, including cultural heritage and environmental evaluations, was completed. The project successfully obtained a planning permit for the necessary native vegetation removal, and required offsets were secured.

Acknowledging budget constraints, the project was strategically divided into two stages. Stage 1 involves the urgent reconstruction of the bridge, coupled with road realignments in the immediate vicinity. Stage 2 focuses on the remaining road realignment, which will be completed as funds become available. By prioritising Stage 1, immediate concerns related to the bridge's structural integrity and safety are addressed.

Tender documentation for Stage 1 was prepared in the final quarter of 2023. Through public advertisement in local and state newspapers, Council invited tenders for the Contract No. 23/24-38 Nagambie-Locksley Road Bridge and Road Reconstruction at Charles Creek Locksley - Stage 1, between 22/11/2023 and 22/12/2023. By the close of tenders at 4.00pm on 22 December 2023, five (5) tender submissions had been received.

Following the tender and assessment process, this report recommends awarding the lump sum contract for Stage 1 to Apex Earthworks Pty Ltd. Their proposal, totalling \$1,854,988.60 (including GST), aligns with project objectives and has been selected based on comprehensive evaluation outcomes.

The recommendation in this report signifies a crucial step towards achieving a safer and more efficient road network within the Strathbogie Shire. It mirrors the municipality's unwavering commitment to maintaining a consistent standard for local transport infrastructure.

The successful execution of this project aims to make a significant contribution to the enhancement of road network access and safety for the community.

# **PURPOSE and BACKGROUND**

Nagambie/Locksley Road serves as a Class 2 Link Road and designated bus route, establishing essential connections between major roads and regions. Identified as a Freight Route by the Council, this road acts as a critical connector for various entities, including Broiler Farms, Mixed farming and grazing areas, Wastewater Management Facility, Transfer Station, Mine, and Arterial Road and Freeway networks. Currently accommodating approximately 347 vehicles per day, of which 17% are commercial, within a 100-km/hr speed zone, the road necessitates a clear zone width of 7.5 meters for optimal safety.

The existing road alignment poses challenges, particularly the narrow width (6.2m) on and around the bridge, compromising safety by reducing visibility and impacting the speed environment. The bridge itself, constructed in 1955 with a subsequent upgrade with concrete overlay in 2004, faces limitations with a current load rating of 44 tonnes. The proposed enhancement aims to raise the load limit to 160 tonnes, accommodating the evolving needs of heavy vehicles. Safety improvements encompass the removal of speed restrictions, addressing roadside hazards, and optimizing road geometry and cross-sectional widths. These enhancements aim to not only meet safety requirements but also facilitate unrestricted access for heavy and oversized vehicles, linking key townships such as Nagambie, Locksley, Longwood, and Euroa to local arterial roads.

The project aims to resolve existing challenges related to cross-sectional widths and roadside hazards. The proposed new bridge is 9.66m in width. Associated road work will feature a total seal width of 10.0 meters with two 3.5m wide traffic lanes. Safety barriers on either side of the bridge will ensure comprehensive safety measures. Beyond infrastructure upgrades, the project aligns with the growing needs of the rapidly expanding Nagambie community, ensuring key access roads are not only fit for purpose but also compliant with evolving safety standards and the increased demands of heavy vehicles.

This report seeks Council approval of the recommendations from the Tender Evaluation exercise on Contract No 23/24-38 Nagambie-Locksley Road Bridge and Road Reconstruction at Charles Creek Locksley Stage 1, and to award the contract to Apex Earthworks Pty Ltd.

# **Tender Process**

The tender was advertised in Saturday's The Age newspaper (state-wide reach), and Shepparton News in the week following release. By the close of tenders at 4.00pm on 22 December 2023, five (5) tender submissions had been received.

All tender submissions were assessed for their compliance including the contractual terms, conditions, and the requirements of the response schedules. All tender submissions were deemed conforming.

# **Panel Assessment Process**

In accordance with Council's Procurement Policy, the evaluation panel and evaluation criteria weightings were determined prior to release of the Tender documentation. The evaluation panel members were nominated prior to release of the tender submissions for evaluation. The panel signed 'Conflict of Interest' statements prior to the evaluation panel viewing the submitted tenders.

The Tender Evaluation Panel members were made up of the following Strathbogie Shire Council officers as follows:

- 1. Director Sustainable Infrastructure
- 2. Manager, Project Delivery Sustainable Infrastructure

### • Tendered Price (60%)

The purpose of the moderation meeting is to discuss and moderate scoring discrepancies larger than three (3) points and to raise any concerns and/or queries that may need to be put to the tenderers prior to recommending the preferred Tenderer.

The Tender Evaluation Panel individually reviewed all tender submissions in detail and assessed tenderers submitted schedules and attachments against the evaluation criteria.

The Moderator (Procurement & Tender Officer) averaged the scores and highlighted scoring discrepancies larger than three (3) points. On Monday 22 January 2024 the Panel members and the Moderator met to finalise the evaluation.

# **Panel Assessment Summary**

At the completion of the tender evaluation process, Apex Earthworks Pty Ltd attained the highest ranking with a total score of 75.48%. All other tenderers scored significantly below the Apex total in either criteria of selection.

They have completed similar works for other regional councils in the past, based on their submission. The submitted tender methodology, program schedule and traffic detour route comply with the contract requirements and provide a clear understanding of the specified requirements.
